ShareFile Accessibility:

ShareFile is a secure and simple cloud-based solution which we use to share information with our clients and their advisors. Each client has their own dedicated portal or folder containing sub-folders which organize plan information to allow for easy access to the particular information being sought.

Here is a listing of the ShareFile sub-folders, along with an description of the confidential contents contained in each of the folders.

ShareFile Accessibility (continued)

Recently ShareFile has been enhanced to limit access to certain sub-folders if the "owner" (i.e., our client) so desires. We have sent out letters to each of our clients about these enhancements. Along with the letter is a listing showing those individuals with ShareFile permissions. Checkboxes are included so that the "owner" can specify whether a particular individual on the list is to be allowed access to all folders or only "non-confidential" folders. For example, an owner may want to delegate responsibility to an individual in the company to access and distribute required notices to plan participants. We can set up this individual in ShareFile to be allowed access to only non-confidential sub-folders within the portal.
